



Members of the Kentucky Adult League Committee are responsible for the organization and administration of the Adult League Tennis programs throughout the state. Each geographical area receives one representative per 1,000 players up to a maximum of five representatives.

The Kentucky "Adult League Committee" member's term will be for 2 years. Community Tennis Associations may suggest new candidates by asking their candidates to submit a USTA Kentucky Volunteer Information Form. These candidates will be considered in the selection process by the USTA Kentucky President. If a member of the Kentucky "Adult League Committee" resigns mid-term, an appointed replacement will serve the remainder of that term.
